## NATIONAL GOVERNORS MEETING FEBRUARY 25, 2012

Recognition was given to Patrick Dolan for being elected to the Corvette Hall of Fame at the National Corvette Museum.

Paul Haack – VP of Comp – encouraged event safety – not to be shy about bring up safety concerns. Competition season has started for 2012 and results will be updated on a monthly basis. Thus far there are 638 sanctions scheduled for 2012. There is now a National Calendar for all Sanctioned Events and is posted on the NCCC website. He also mentioned that airport regulations have changed for 2012. Rulebook clarifications were given – see Craig's notes for details.

Larry Morrison – VP of Membership – Asked that Gov's please ask members to keep their addresses up-to-date. When Governors change their email addresses also let Larry know as email blasts go thru all Governors to reach their club membership. To date, we have 13,290 members with 265 clubs. Ron Ruston – Sgt-at-Arms – Currently working on the electronic ballot system. Will be doing one more test mid summer.
