Rigs & Cars may be left at the track both nights; along with utilizing your own sleeping facilities if desired.

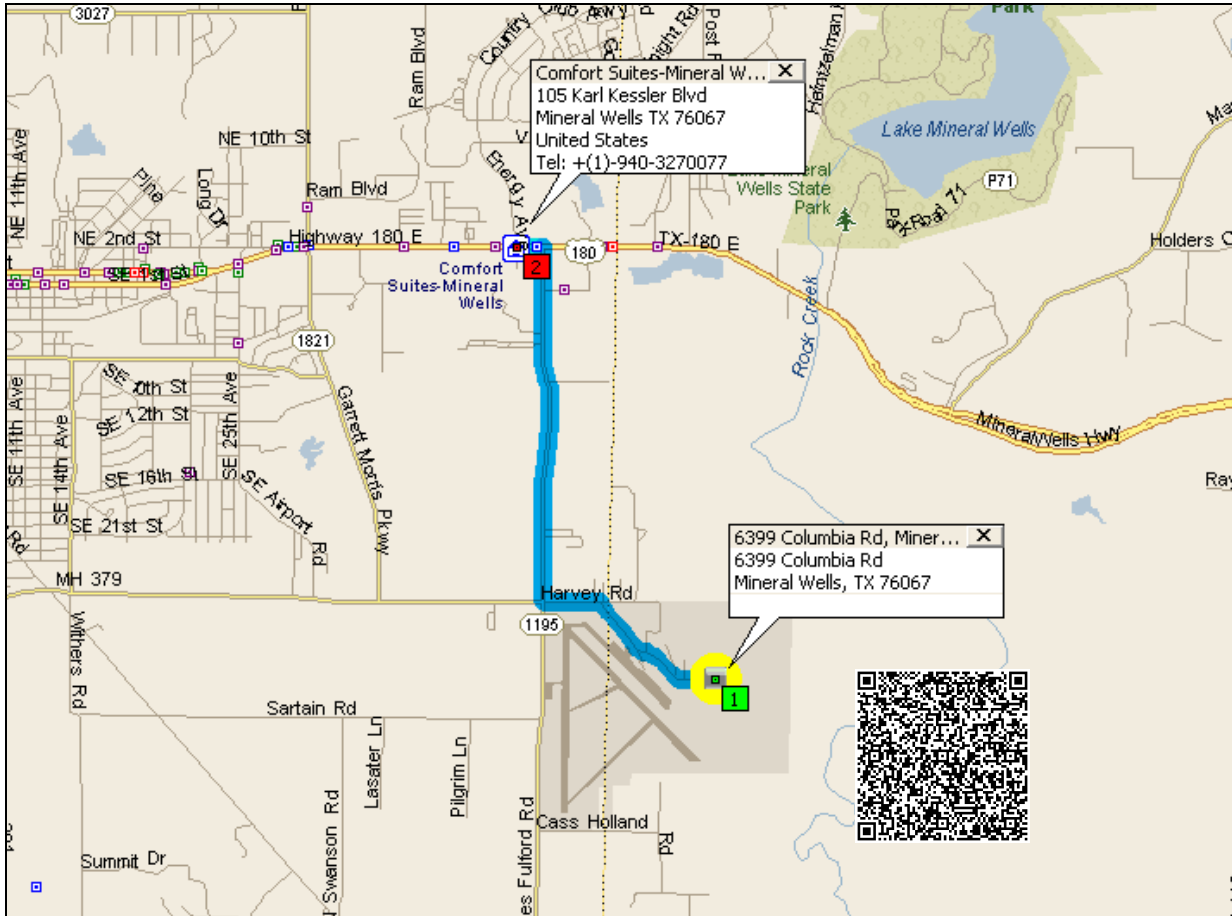
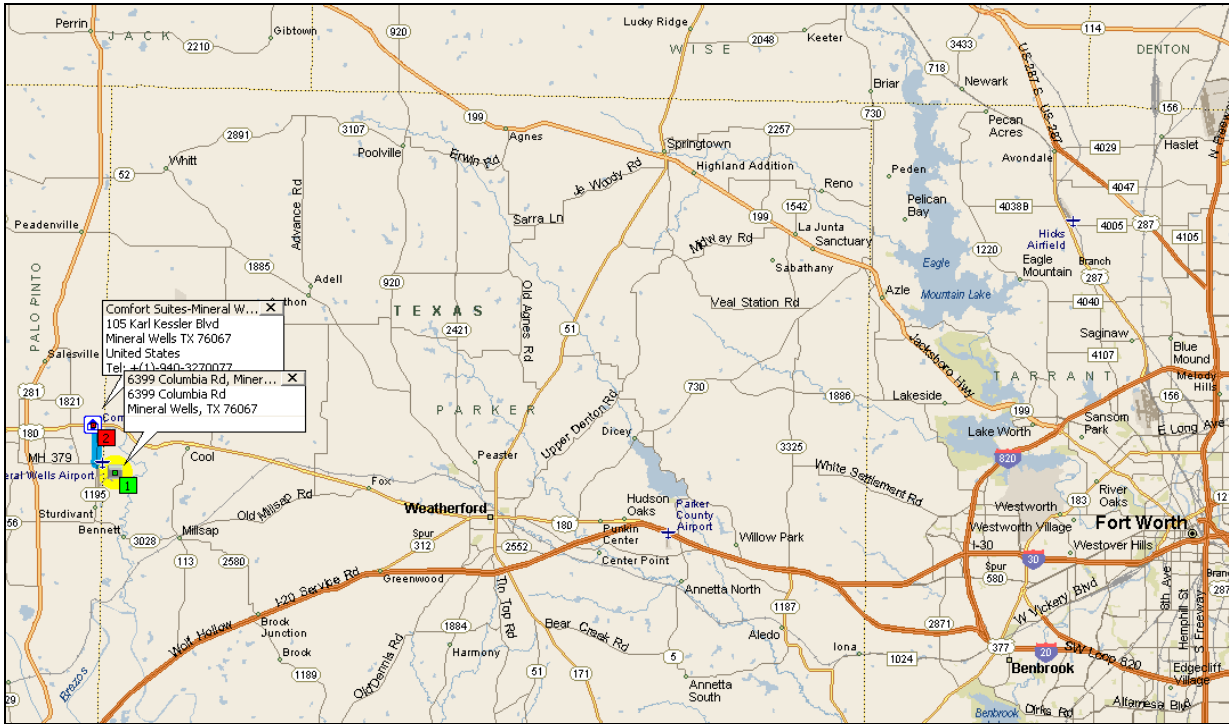
